



# Official Contest Rules:

## Lake County Ca Getaway

**AGREEMENT TO RULES:** Participation in the **Lake County CA Getaway** (“Sweepstakes”) constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of Lake County Tourism Improvement District which are final and binding.

**ELIGIBILITY AND RESTRICTIONS:** Sweepstakes is open to people 21 years of age or older who are legal residents of the 50 United States and District of Columbia, except where prohibited by law. Sweepstakes is subject to all federal, state and local laws and regulations and is void outside of the 50 United States and the District of Columbia and where prohibited by law.

**HOW TO ENTER:** No purchase necessary to enter or win. Giveaway is open from November 11, 2023, 12:00 AM PST and closes on November 30, 2023, 11:59 PM PST. You may also print and mail your entry with your name, address, email address, phone number and date of birth to Visit Lake County CA, PO Box 712 Lakeport, CA 95453. Paper entries must be received no later than November 30, 2023. Limit one entry per person and per household. Entries must be legible to be valid. Sponsor is not responsible for typographical or printing errors, lost, late, damaged, undeliverable or misdirected entries or postage-due mail. Entry forms distributed where prohibited by law, or not obtained lawfully, will be null and void. All entries become the exclusive property of Sponsor and will not be returned.
